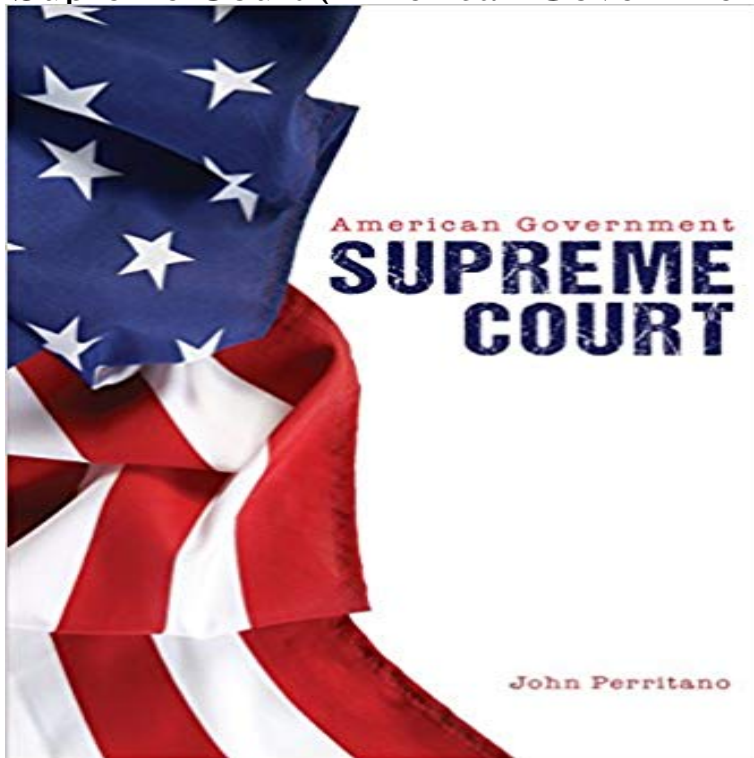


Supreme Court (American Government Handbooks)
