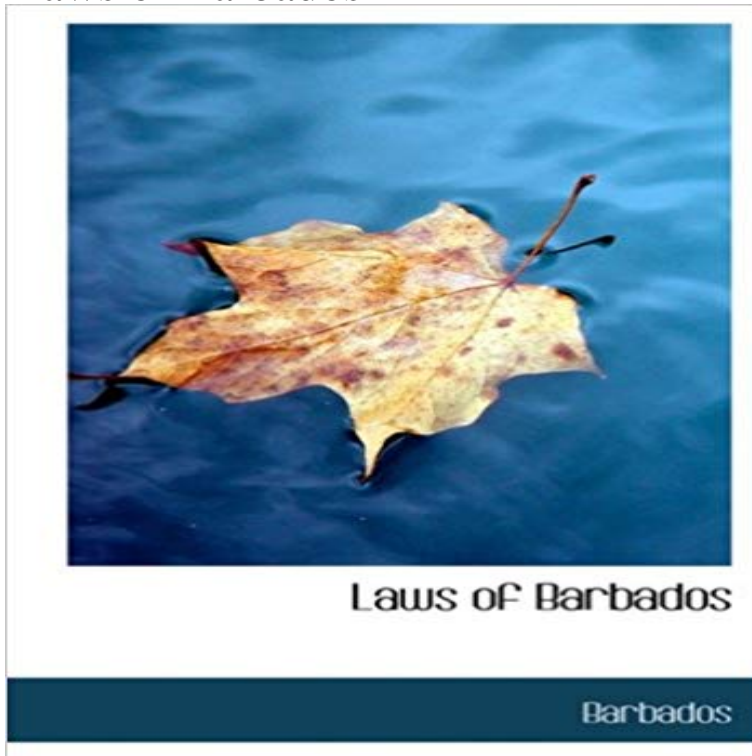


## Laws of Barbados
