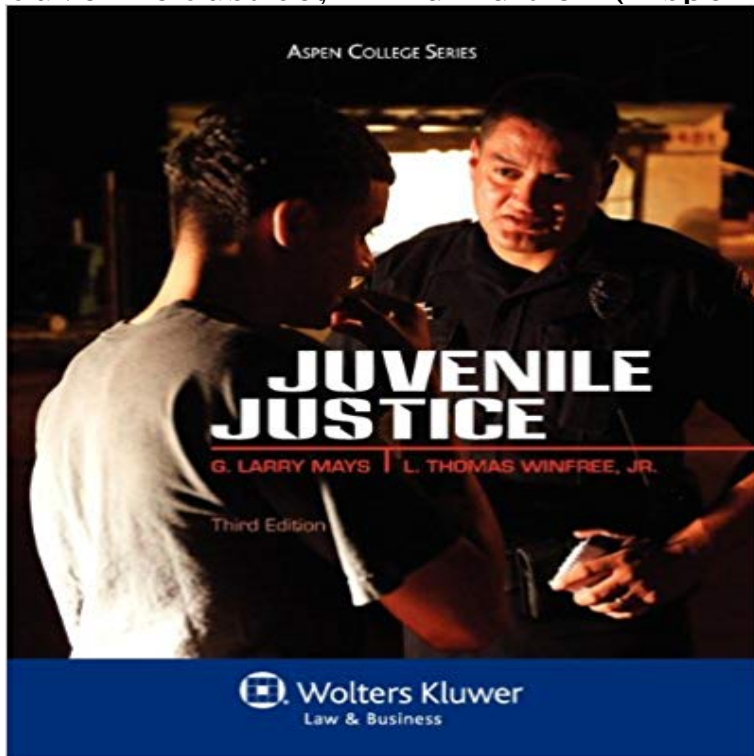


Juvenile Justice, Third Edition (Aspen College)
