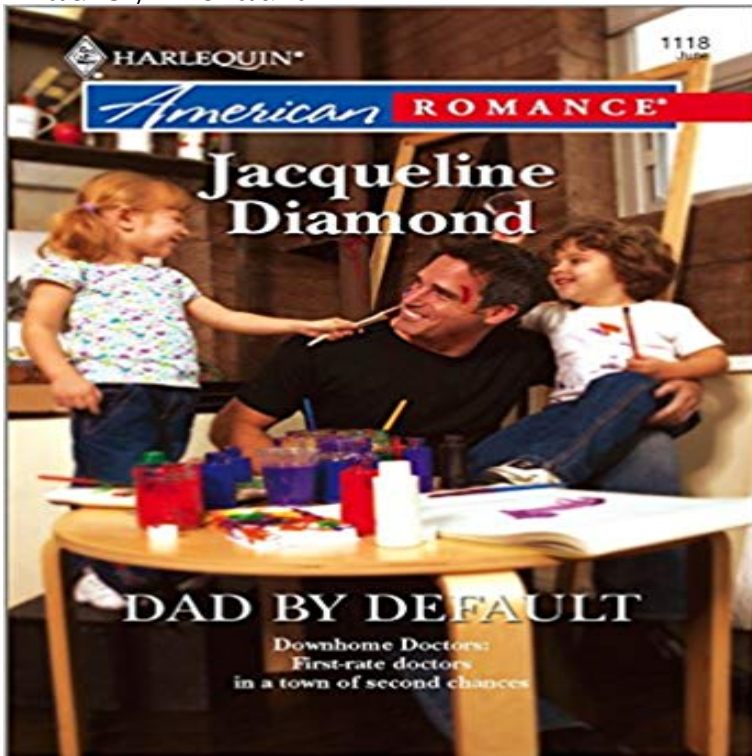


## Dad by Default
