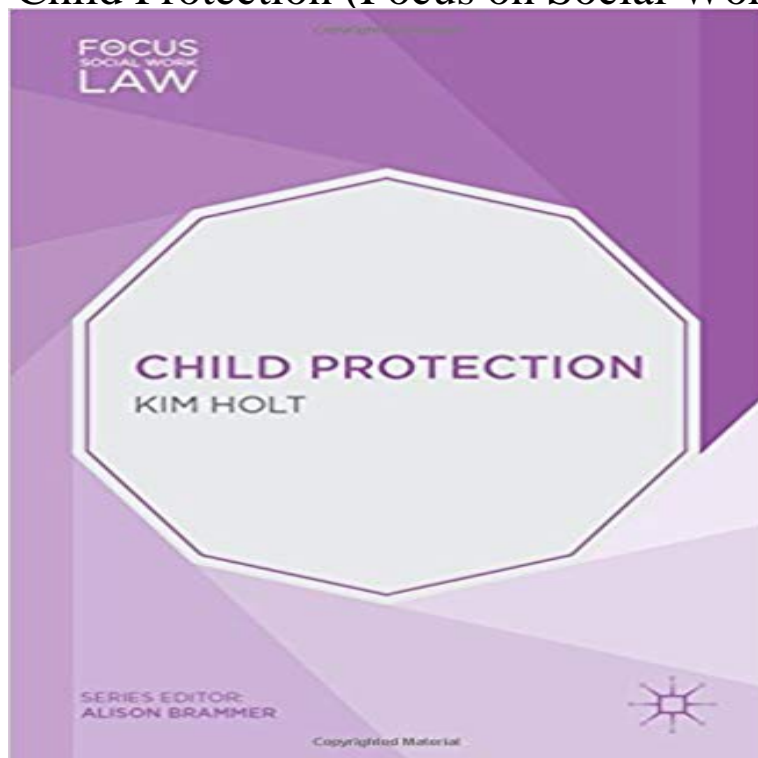


Child Protection (Focus on Social Work Law)
