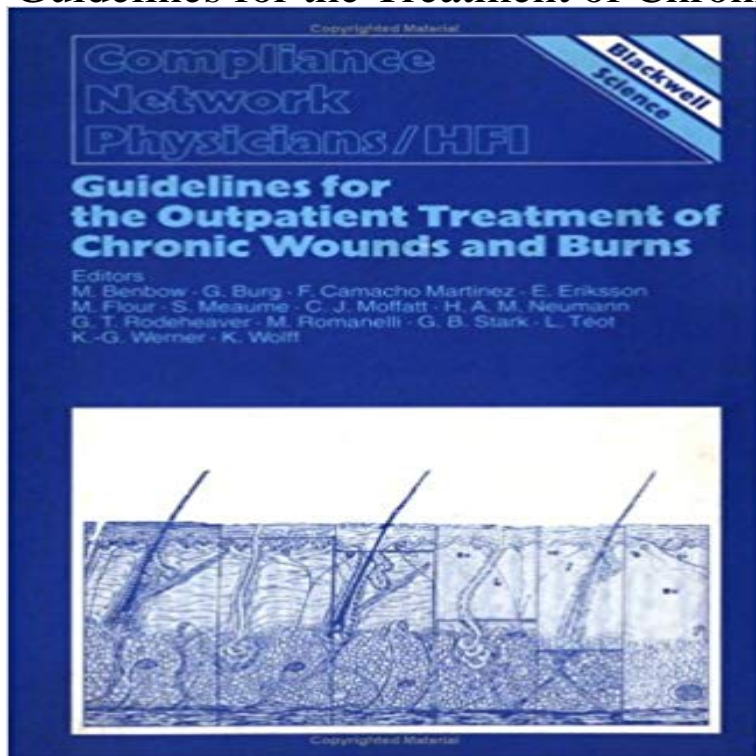


## Guidelines for the Treatment of Chronic Wounds and Burns
