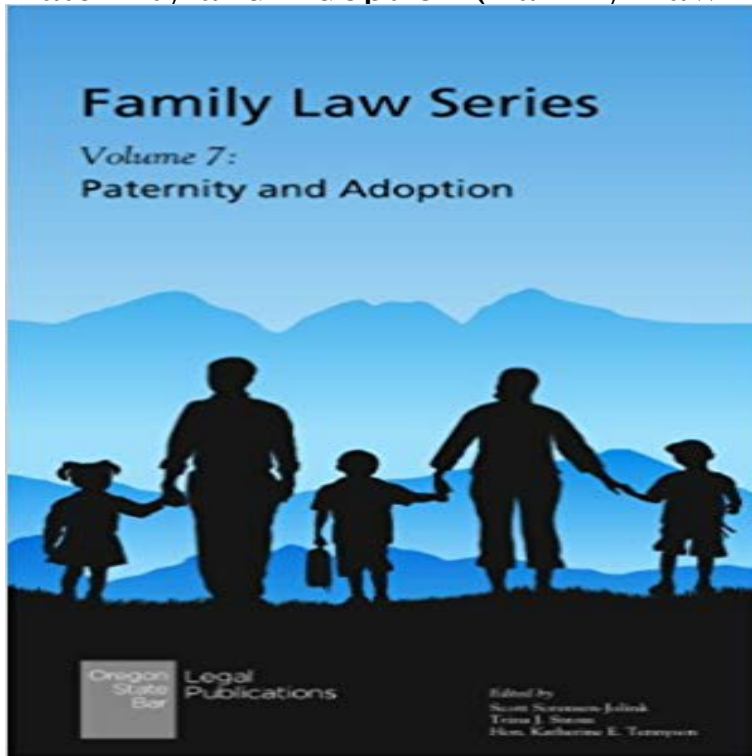


## Paternity and Adoption (Family Law Book 7)
