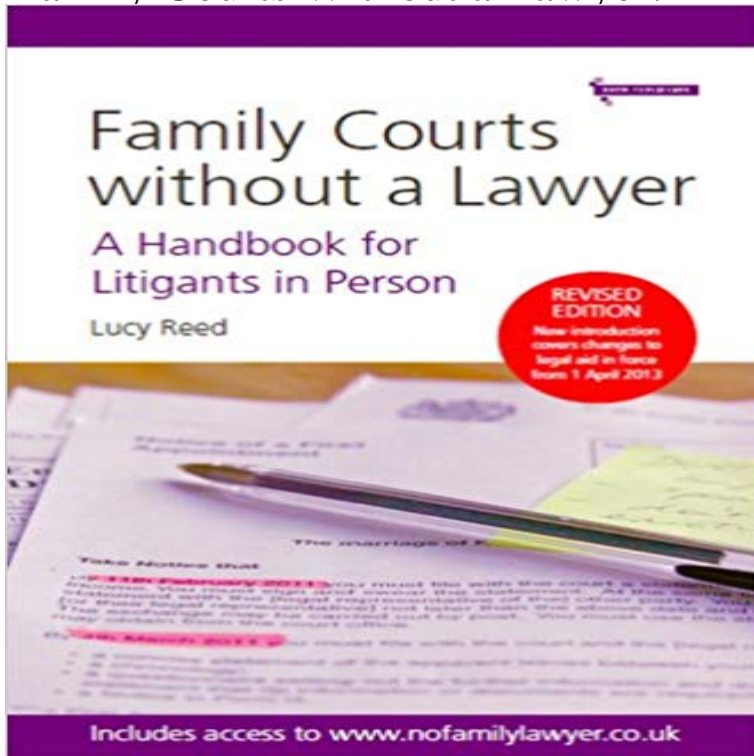


Family Courts Without a Lawyer: A Handbook for Litigants in Person
