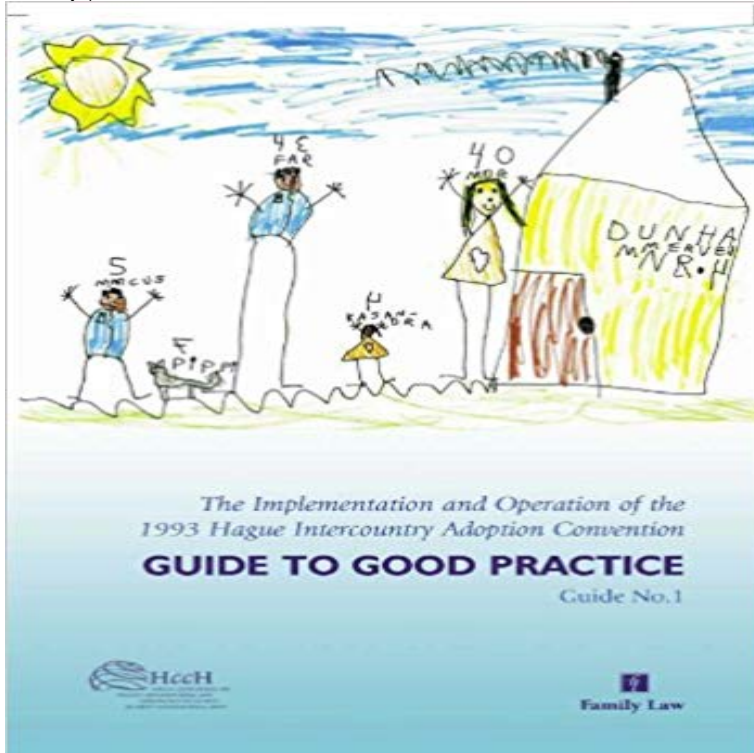


# Hague Conference Guide to Good Practice on Intercountry Adoption
