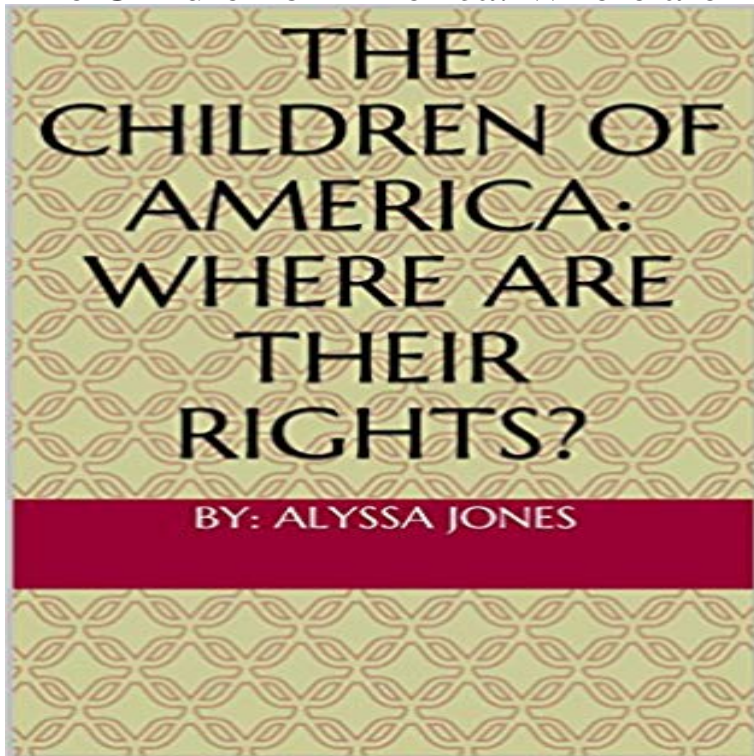


# The Children of America: Where are Their Rights?
